  - Nicole Kurtz is on a provincial committee called, 'SIP and SEA Review Special Education funding Committee'. Nicole reviewed some of the feedback provincially on SIP and SEA claims as well as sought further feedback from the SEAC committee that will be brought forward to the provincial committee.
     Some of the feedback already given to the Ministry from School Boards across Ontario:
    - Privacy concerns with students' personal information being transferred from the school board to the Ministry.
    - o Funding is not sufficient to support the student.
    - o The process to apply for SIP funding is very labour intensive.
    - The SIP funding is not equitable to different classroom delivery models. So instead of being
      inclusive and having the student in the classroom with their classmates, the funding has to be
      put into a specific classroom where the special equipment is set up.
    - o The lack of qualified education assistants. Enrollment in college programs is down significantly.

#### 6. Professional Development:

Special Incident Portion (SIP) Funding - Andrea Batters

The claims are designed to support children who have very complex and extraordinarily high health and/or safety needs. This funding is eligible for students who require more than two full-time equivalent board-paid staff providing intensive support for the health and/or safety of the child, [other pupils, and/or staff]. Staff supporting learners with high special education needs assist students with all aspects of school life, throughout their day-to-day activities. They help the child attend class, ensure safety, and assist with complex medical needs.

To create a SIP claim, information needs to be gathered such as: medical documentation, clinical reports, Individual Education Plans (IEPs), Safe and Successful Day Plans, and the student support level timetable, which documents the role of each professional working with the student at what time according to their needs. This information needs to be entered into a Ministry spreadsheet each fall and all documentation is sent to the boards Regional Ministry Office in December, on an annual basis. Boards submit their estimated funding for all SIP claims in their Revised [special funding] Estimates to the Education Finance Information System (EFIS). The Ministry reviews the information and if funding is granted, they notify boards of their final approved SIP funding amounts by the end of August each year. The maximum funding amount boards are eligible to receive for SIP funding is equivalent to a portion of the cost of the wage of *one* board-hired support staff employee.

Special Equipment Amount (SEA) Claims - Andrea Batters

The Special Equipment Amount has two channels of funding:

- · Per pupil amount for educational technology for use by students with special education needs
- Special Equipment Amount, Individual Claims, non-technology for all other equipment required for the student to access their learning program and/or attend school safely.

During the past month, several Learning Resource Teachers (LRTs) have been able to participate in the **Empower Reading Program** training. The **Primary Empower Reading Decoding & Spelling program** is a series of evidence-based reading intervention programs geared to students who are suited to this daily withdrawal intervention support. This program was developed over years of research and studies by a team of researchers and educators at Sickkids. The program targets elementary learners with significant reading and spelling challenges and teaches them strategies which help them become independent and flexible learners. Trained LRTs work with groups of up to eight students for an hour a day to learn rigorous, evidence-based reading strategies.

Through a **regional PD partnership** led by Keewatin Patricia DSB and joined by the KCDSB and The Northwest Catholic DSB, Karen Smith (new LRT at St. Louis Living Arts School) and several participants from our area were able to complete the initial two-day **Primary Empower Reading Program training,** which was held in Dryden. Usually this PD takes place virtually, so it was a wonderful experience for Karen to be able to join the Empower Trainers and this professional learning community in person.

Additionally, in respect to the Empower Literacy program, the annual 'refresher' training was attended virtually by Shawna Lamme (SJS LRT), Anissa Fraser (SJPII LRT), and Kristy Smith (ESMB LRT).

# **Evidence-Based Literacy Intervention Program Updates**

The Literacy Lead teachers and several of us system instructional leads/coordinators are continuing to assist classroom teachers in monitoring and delivering Tier 1 or Whole Class evidence-based literacy programs which employ the principles of universal design for learning (UDL) and differentiated instruction (DI), based on ongoing program data collected. Programs include: Fundations (K-3), Heggerty (phonemic awareness) and Lexia Core5 (Gr. 1-5) and PowerUp (Gr. 6+) Structured Literacy Programs.
